- 4. Copy of result cards and "Bay"Form, FRC, Birth Certificate will be provided.
- 5. At the time of meeting, the original register of Union Council/Cantonment Board/Corporation and School will be provided.
- 6. Once the name has been changed, it cannot be changed again.
